The mission of the One Love Foundation in Honor of Yeardley Love is to end relationship violence by educating, empowering and activating young people in a movement for change. One Love was created to honor Yeardley Love, a University of Virginia senior who was beaten to death by her ex-boyfriend just three weeks before graduation. After her death, Yeardley's family and friends were shocked to learn the statistics that 1 in 3 women will be in an abusive relationship in her lifetime and that young women ages 16-24 are at 3X greater risk. In the years following, they grew determined to change these statistics. Our emergence from a local organization to a national player has been due to the power of the tools that we create and the strategy that we are deploying to address an issue that literally touches everyone in this country in some way.

Escalation

Our campaign to end relationship violence is centered on Escalation, a powerful film-based workshop that has been incredibly well received by students. The Escalation workshop is a 90-minute curriculum that consists of two core elements: (1) a powerful film that dramatically depicts a college relationship from its exciting beginning to a tragic end, and (2) a peer-facilitated discussion that stimulates important conversation among students about relationship violence in their lives. We are bringing Escalation to campuses across the country because we believe that it is making a large impact and early evidence shows it is inspiring students to want to get deeply involved in this issue. During testing, 97% of participants said they would recommend the workshop to a friend even if it wasn't required and nearly 90% suggested that it should be required viewing for all college students. This enthusiasm is driving rapid adoption of the workshop as an educational tool on

campuses. Our goal is to bring Escalation to every community we can as quickly as we can, sparking an awakening around this issue and a deep commitment to change. As far as know, there is no other organization employing these strategies to meet this demographic where they are.

Recognizing the importance of new content and campaigns to maintain interest in One Love's message, work began in the fall of 2014 to determine how a new digital/social media campaign could help engage and activate young people in our movement for change. We were fortunate to engage TBWA/Media Arts Lab (MAL\FOR GOOD) as our partner in this campaign in early 2015. The concept they developed, #ThatsNotLove, is a series of innovative and even entertaining sub-campaigns designed to label the behaviors that comprise unhealthy relationships. These campaigns are specifically designed to reach young people and engage them in discussion about abuse. They are distributed digitally and accessible to anyone, not just individuals in school. The first sub-campaign - "Because I Love You" - has been viewed over five million times since it was launched in October. #ThatsNotLove made the list on The Pixel Project's "16 Striking Anti-Violence Campaigns for the Cause to End Violence Against Women", which recognizes anti-violence campaigns across the world. The Foundation was the only campaign on the list from the United States. The Pixel Project (www.pixelproject.net) is a sponsor of the National Coalition Against Domestic Violence. Of even more interest, the quality of conversation shared in the comments on YouTube and Facebook demonstrate that the campaign struck a chord. Additionally, we were inundated with requests to bring Escalation to campuses after "Because I Love You" launched. We are thrilled with this response and are eager to build out this suite of shareable awareness pieces with three additional sub-campaigns in the first half of 2016.

In December 2014, the collegiate lacrosse community started the Million Yards for Yeadley campaign. Originally conceived by two teams, the campaign ultimately engaged 150 men's and women's college lacrosse teams in running and tracking yards to show their dedication to the movement to end relationship violence, One Love, and Yeadley. In February, ESPNW wrote a story about the Yards for Yeadley movement because they were inspired to see kids taking on this issue in an impactful way.

We are thrilled that the lacrosse community has launched a second Million Yards for Yeadley campaign this January with even bigger goals than last year. Million Yards for Yeadley is a perfect example of the sort of student-driven concept that we want to amplify. We are building on the concept, by encouraging other sports teams and any individual who wants to participate in the run as part of Team One Love. In 2016, we will launch an app to facilitate future Yards for Yeadley efforts by simplifying yardage capture as well as offering ways users can get others involved. The app will ultimately include the ability to set personal and team challenges, challenge other individuals and teams, share educational content, and even raise funds for One Love's work. We are also positioning Yards for Yeadley as a core Team One Love activation initiative, encouraging students to run day long or week long Yards for Yeadley challenges at their schools.

Building a Movement - Team One Love

The 2015/2016 school year marks the official launch of Team One Love, through which motivated students join the movement to end relationship violence as leaders on their campuses in working for change. Team One Love members help One Love distribute Escalation on their campuses and help amplify One Love's other campaigns, #ThatsNotLove and Yards for Yeardley. They are also encouraged to come up with their own activation concepts that are customized for their campus cultures and communities. We have been thrilled at the growth of Team One Love in the first part of the school year. Students on campuses across the country have hosted inaugural Team One Love weeks and "Because I Love You" Activation events. There are plans for additional Yards for Yeardley activities in the months to come. We will be hosting an expanded virtual internship program this summer to more deeply engage campus leaders with One Love and to help them come up with campus engagement plans for their schools. Our goal by this time next year is to at least double the number of Team One Loves on campus compared to where we are today. At the time of this filing, we have approximately 40 active Team One Loves and 6,000 members.

Previous Accomplishments:

The "Be1ForChange" campaign was launched in the fall of 2012. This long-term initiative developed in partnership with the Michael and Kim Ward Foundation and the John Hopkins Universities' School of Nursing. The Foundation's public service announcement (PSA) was released in Sept 2012 as a part of their "Be 1 FOR CHANGE" initiative. The PSA received a prestigious gold ADDY Award, the world's largest advertising competition, in the category of "integrated campaign." The PSA was broadcast over the Comcast network which reached over 3.9 million households in the Northeast and Mid-Atlantic regions. In the last three years, Comcast has donated over \$5 million in
